Behavior Agreement Form

Girlstart is very excited about the opportunity to provide summer enrichment for your child!! To ensure that each and every camper has a great week; we want all of our campers and parents to understand and be familiar with the expectations for participants in Girlstart's Summer Camp. Please read and return to Girlstart on first day of camp.

Camper Expectations

- ✓ **I will cooperate with my counselors and fellow campers in all camp activities.**
- ✓ **I will be responsible for my actions and behavior so that it doesn't interfere with somebody else's opportunity to enjoy camp.**
- ✓ **I will follow all rules established by myself and fellow campers on the Do's & Don't list.**
- ✓ **I will act and speak positively and kindly to all campers and staff (i.e., no swearing, inappropriate remarks, etc.)**
- ✓ **I will listen and not talk when others are talking because I want them to do the same for me.**
- ✓ **I will have FUN, make FRIENDS and LEARN new things all week long!**

Campers who **choose** not to follow the behavior expectations will be given "three strikes" and then dismissed from camp.

Behavior Consequences

- First strike:** Separated from camp activity temporarily. Incident is discussed with camper and documented. Warning issued. Parent/guardian notified by email/phone of incident.
- Second strike:** Separated from camp activity and escorted to Camp Director's office. Incident is discussed with camper and documented. 2nd and final warning issued. Parent/guardian notified by phone immediately.
- Third strike:** Separated from camp activity and escorted to Camp Director's office. Camper dismissed from camp. Parent/guardian notified by phone immediately. Arrangements are made with parent/guardian to pickup camper immediately. *No refund will be provided.*
- No tolerance:** Girlstart reserves the right to immediately dismiss any camper whose actions or behaviors endanger themselves, other campers, or camp staff. Including but not limited to the possession of tobacco, drugs, or alcohol of any kind while at camp. *No refund will be provided.*
